



APPLICATION TO SIT THE COMPETENCY IN OPTOMETRY CULTURAL SAFETY TRAINING

This training will be run online and can be taken in your own home, office or another location chosen by you.

You will need:

- A computer, keyboard and mouse/touchpad
- A stable internet connection
- Power supply

The training consists of six (6) tutorials and assessment tasks. Within the 6 tutorials are 28 short lessons that include videos, activities, definitions, and theory, which are then applied to real-life inspired case studies.

The program is self-paced and you can log in at intervals and complete the training in your own time. Total time commitment is approximately 5 hours, plus assessments.

Assessment consists of interactive quizzes and short answer responses to clinical optometry scenarios. At the end of the program, there is a final multiple-choice exam. To be successful in each assessment, including the exam, candidates must obtain a minimum score of 80%. If you score less than 80% on an assessment or the exam, you can return to the tutorial and review the content before attempting the assessment/ exam again. You can re-take the assessments as often as necessary until you are successful.
